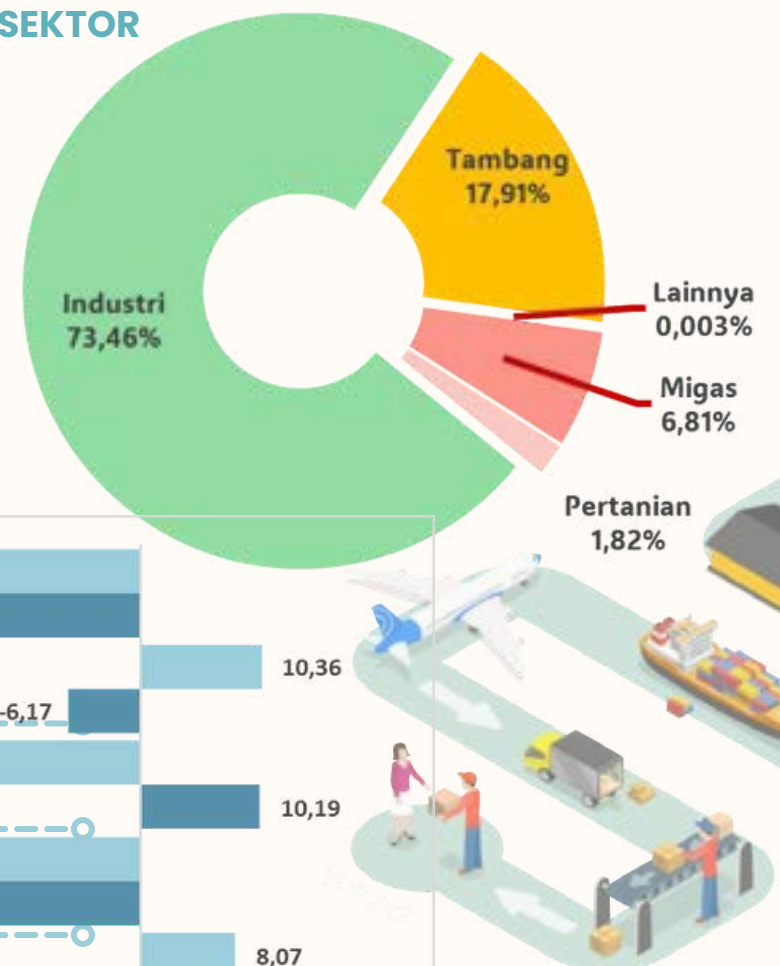

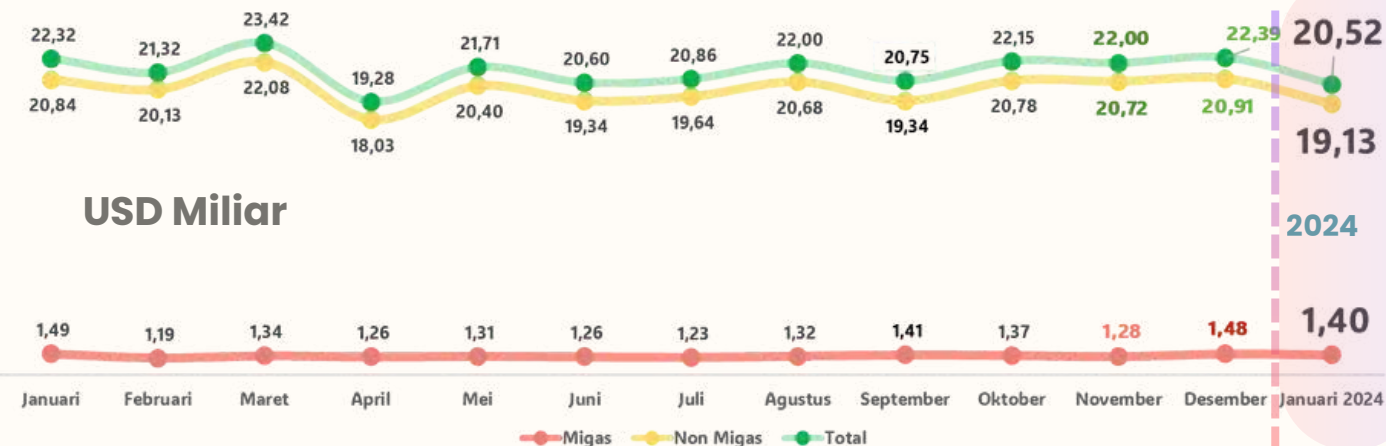

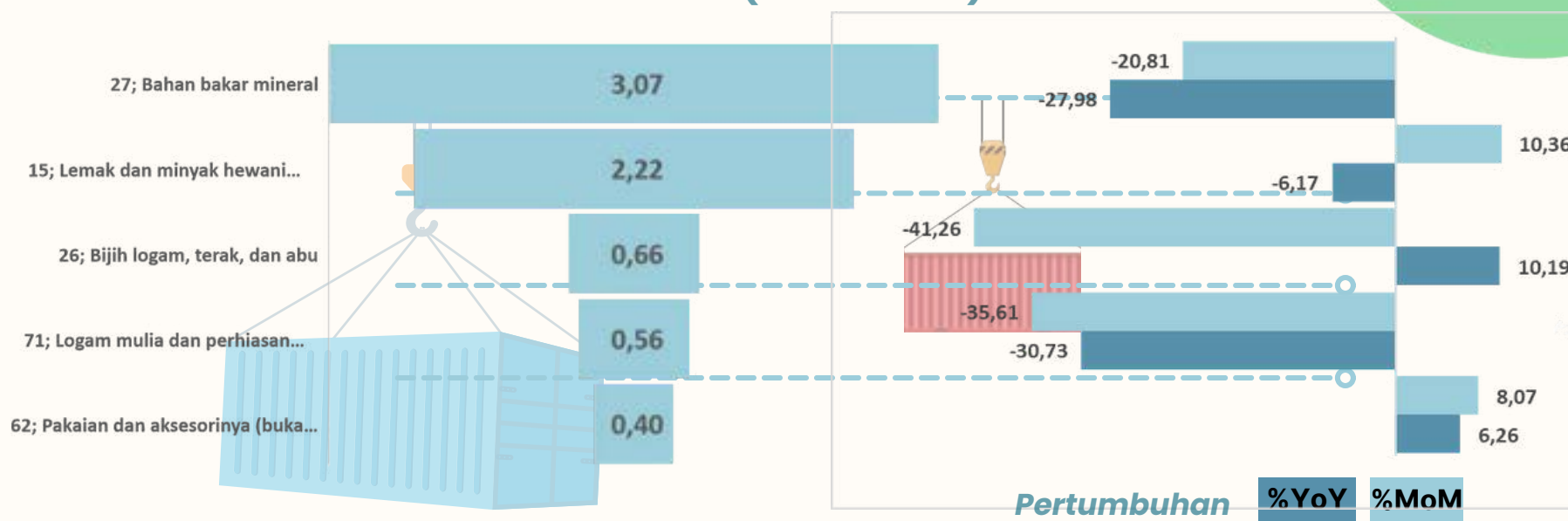

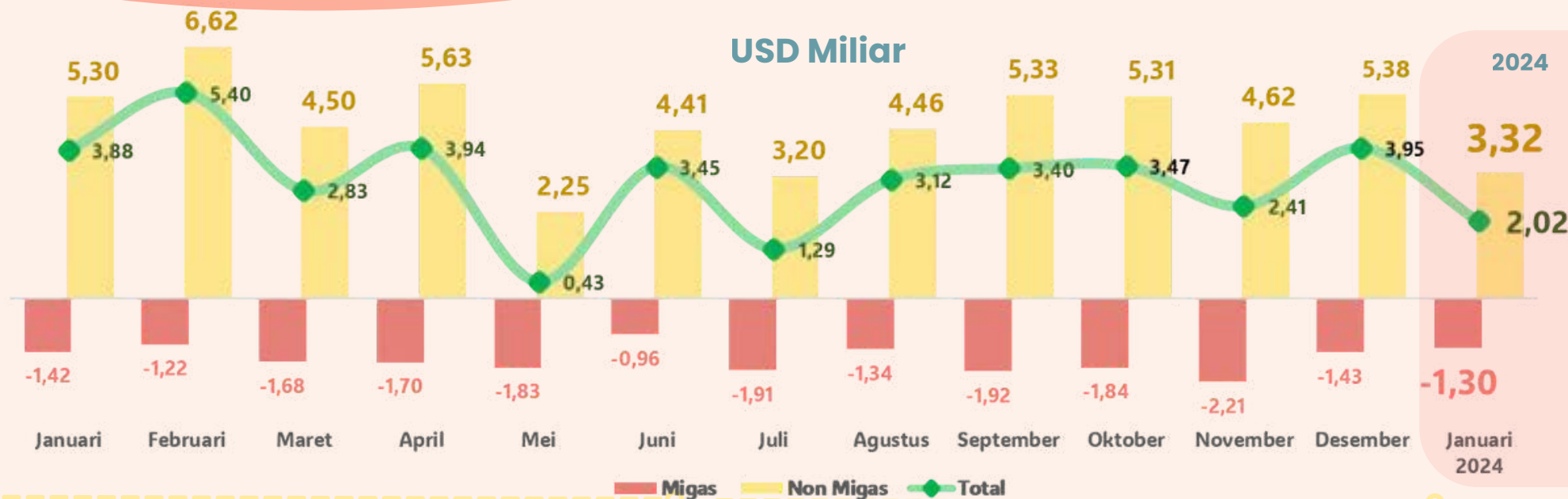

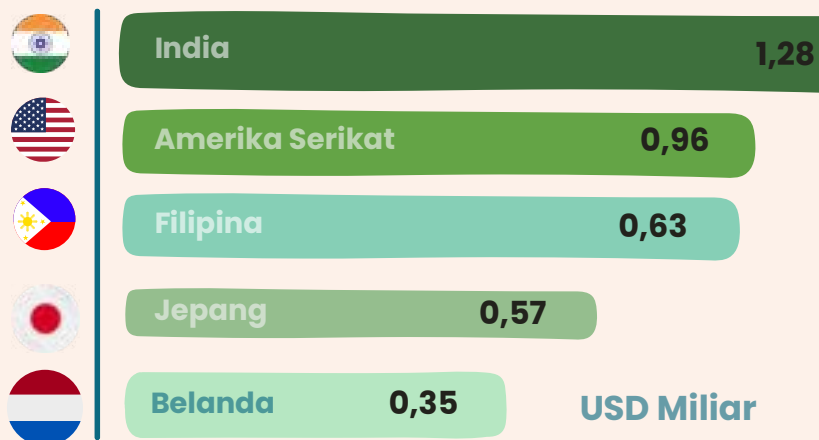

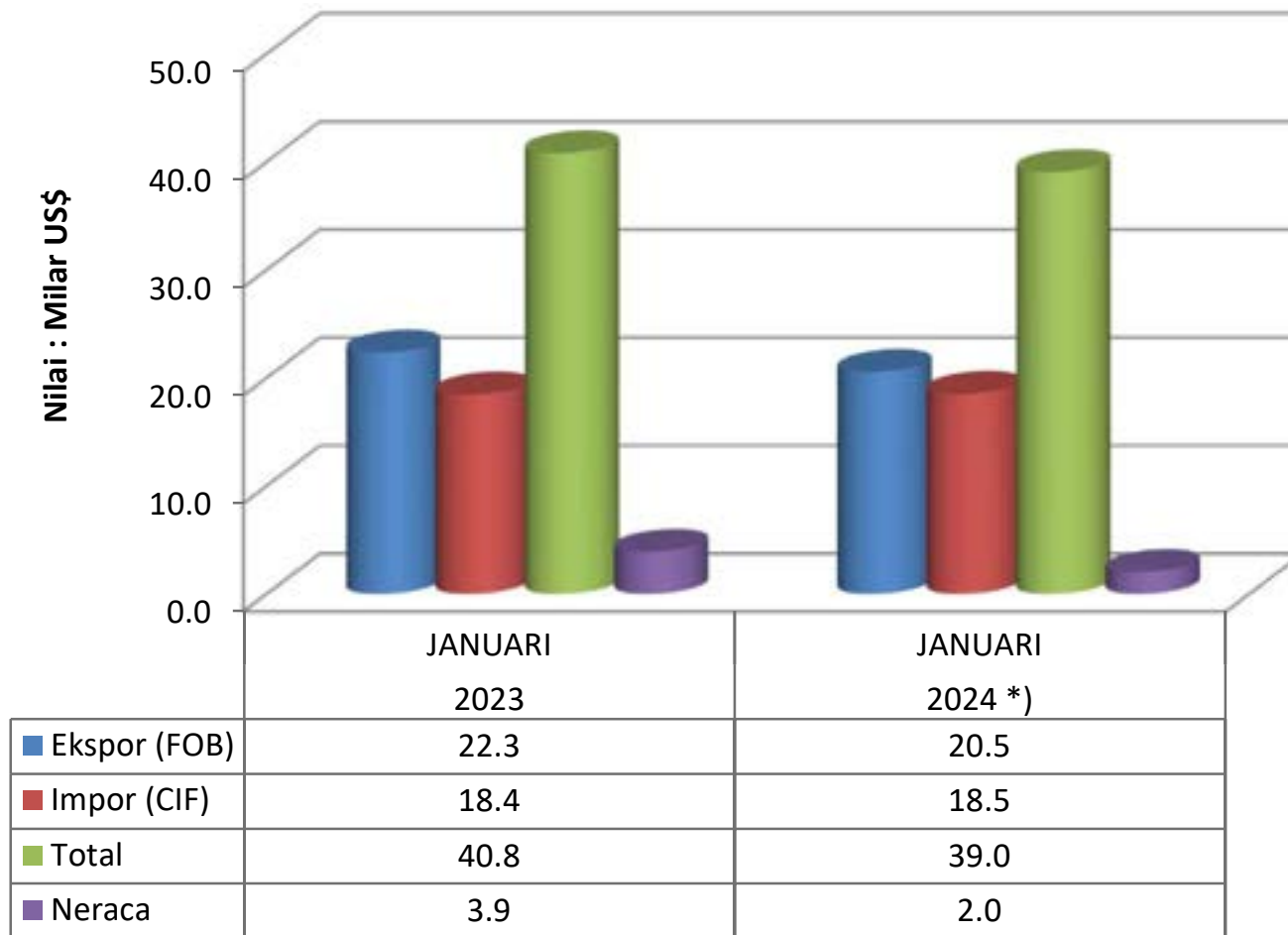

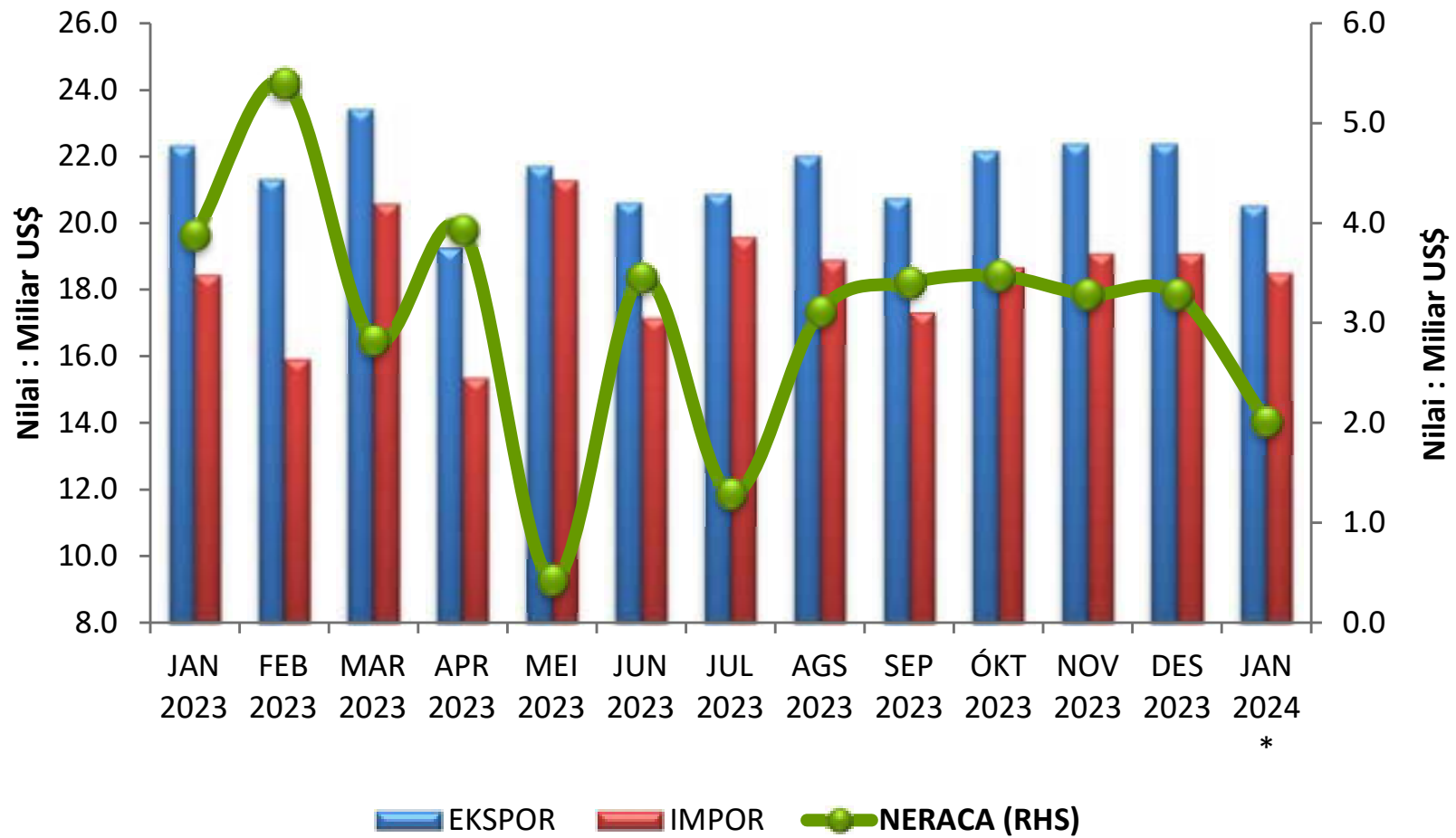

TAHUN 2023 DAN 2024



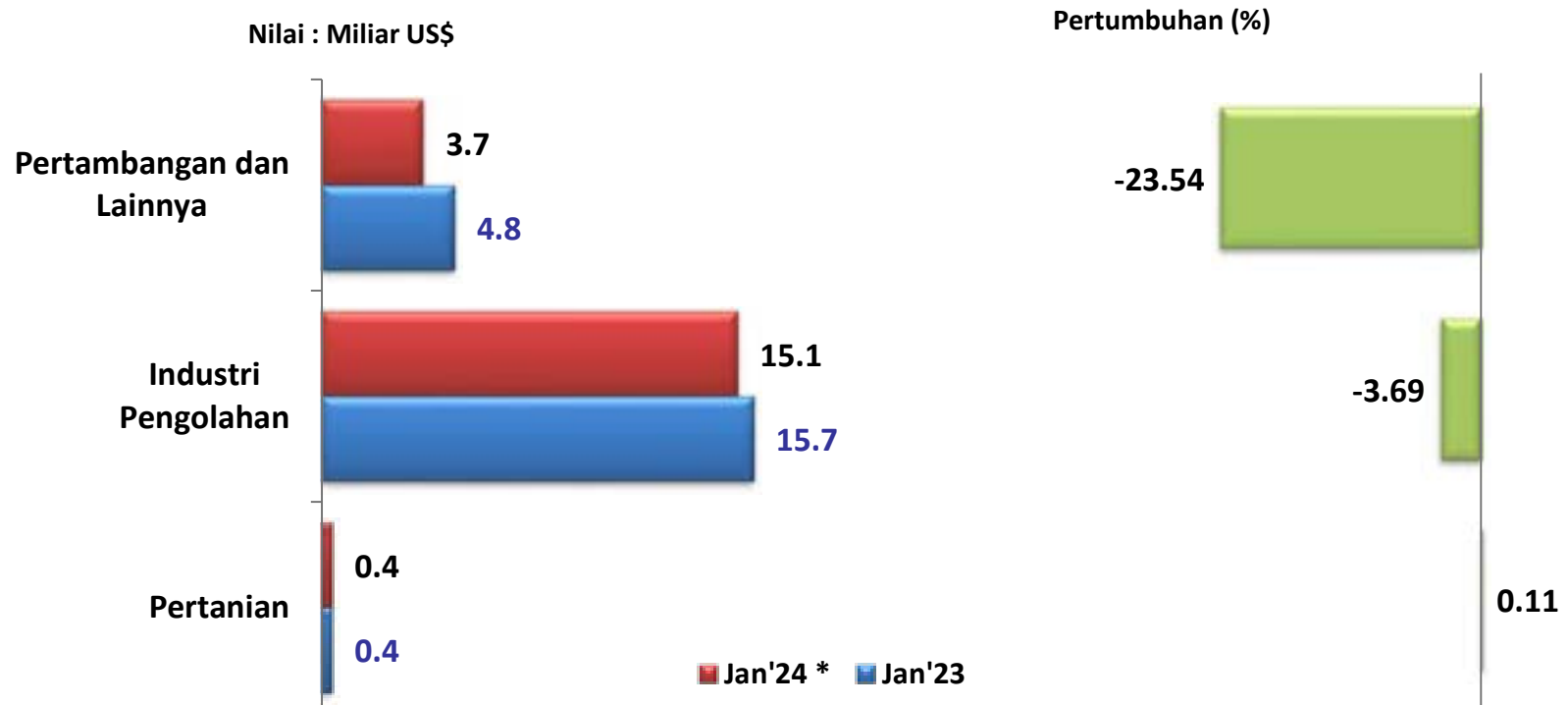

EKSPOR NON MIGAS INDONESIA MENURUT SEKTOR



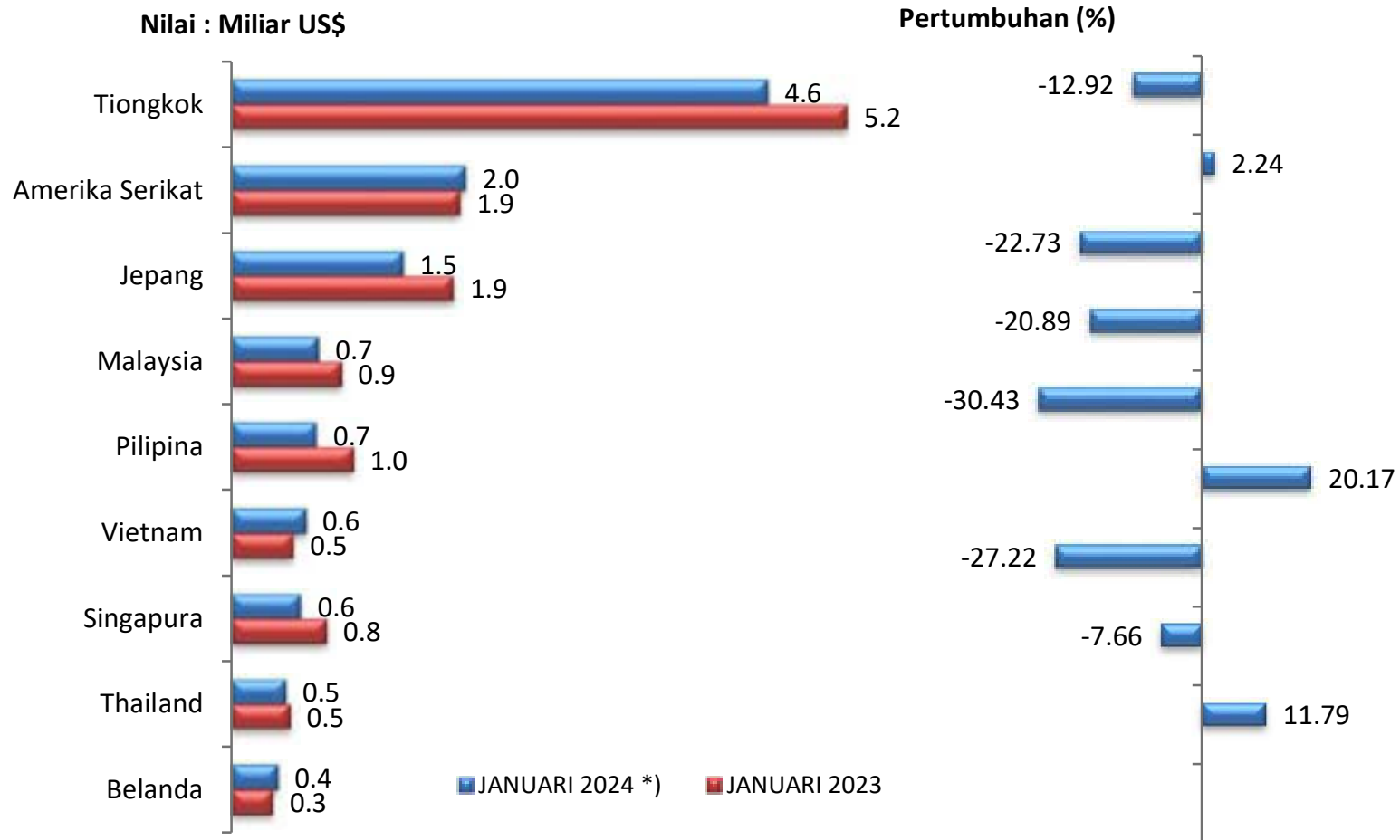

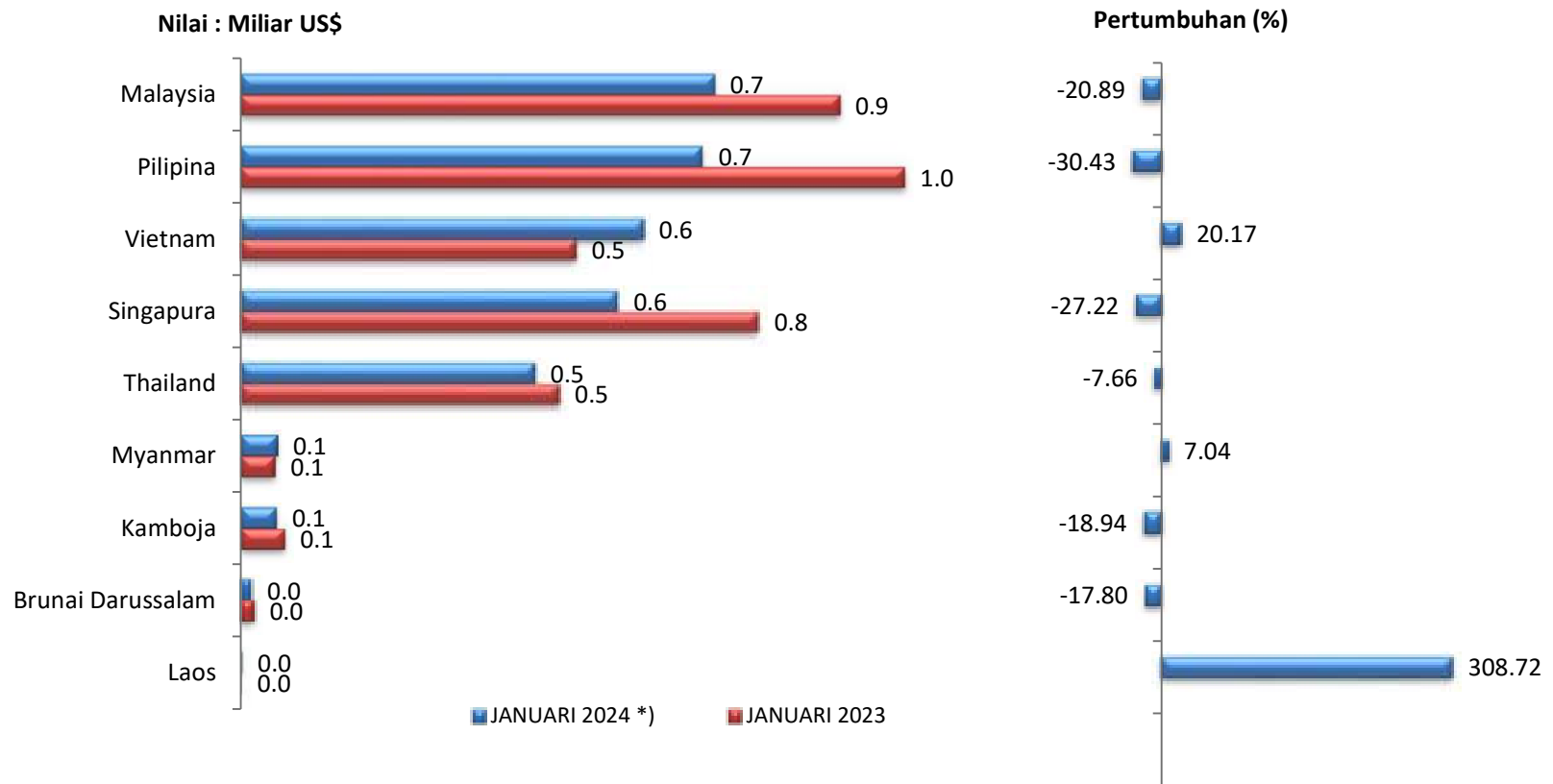

EKSPOR NON MIGAS INDONESIA DENGAN ASEAN



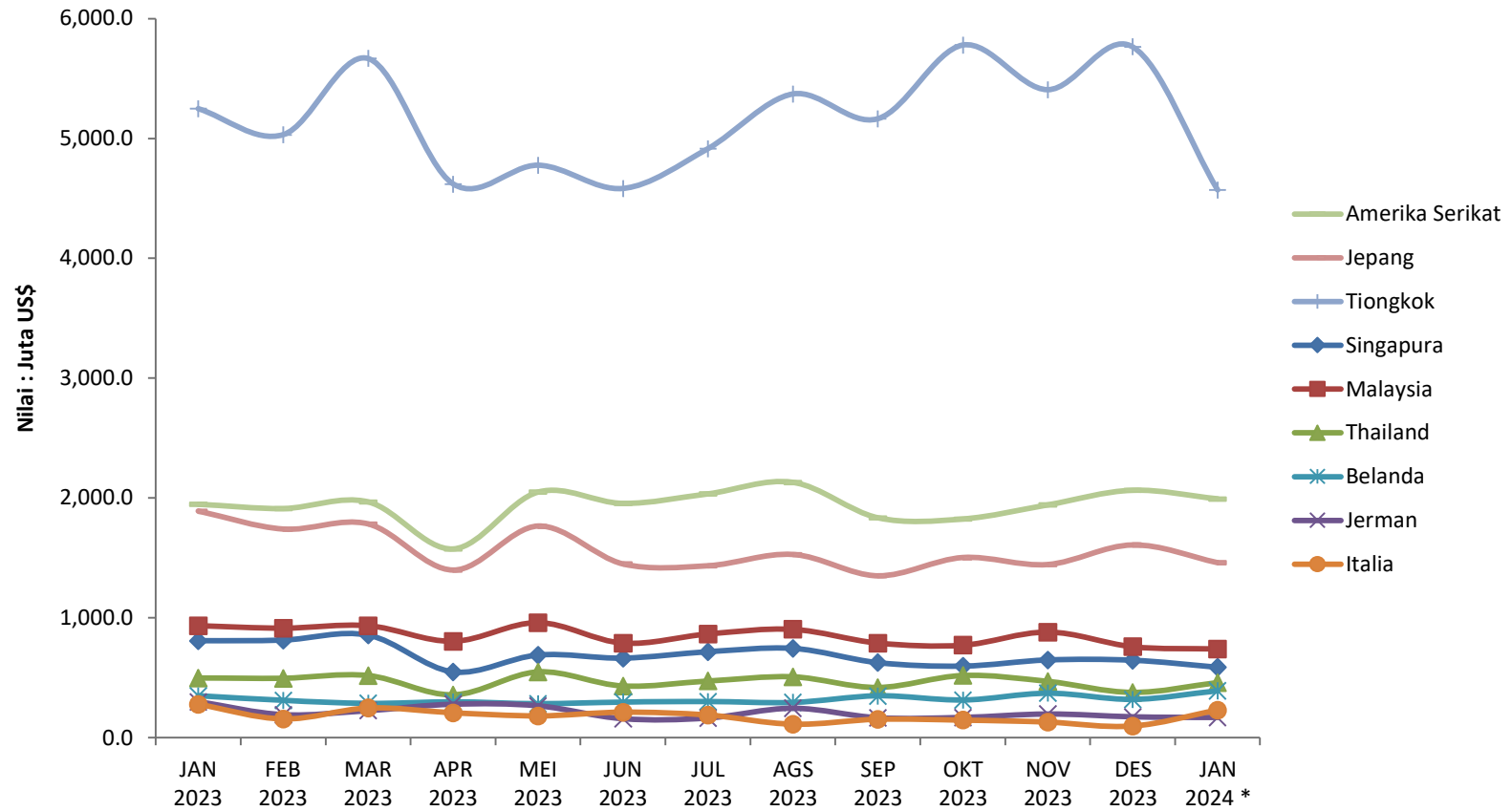

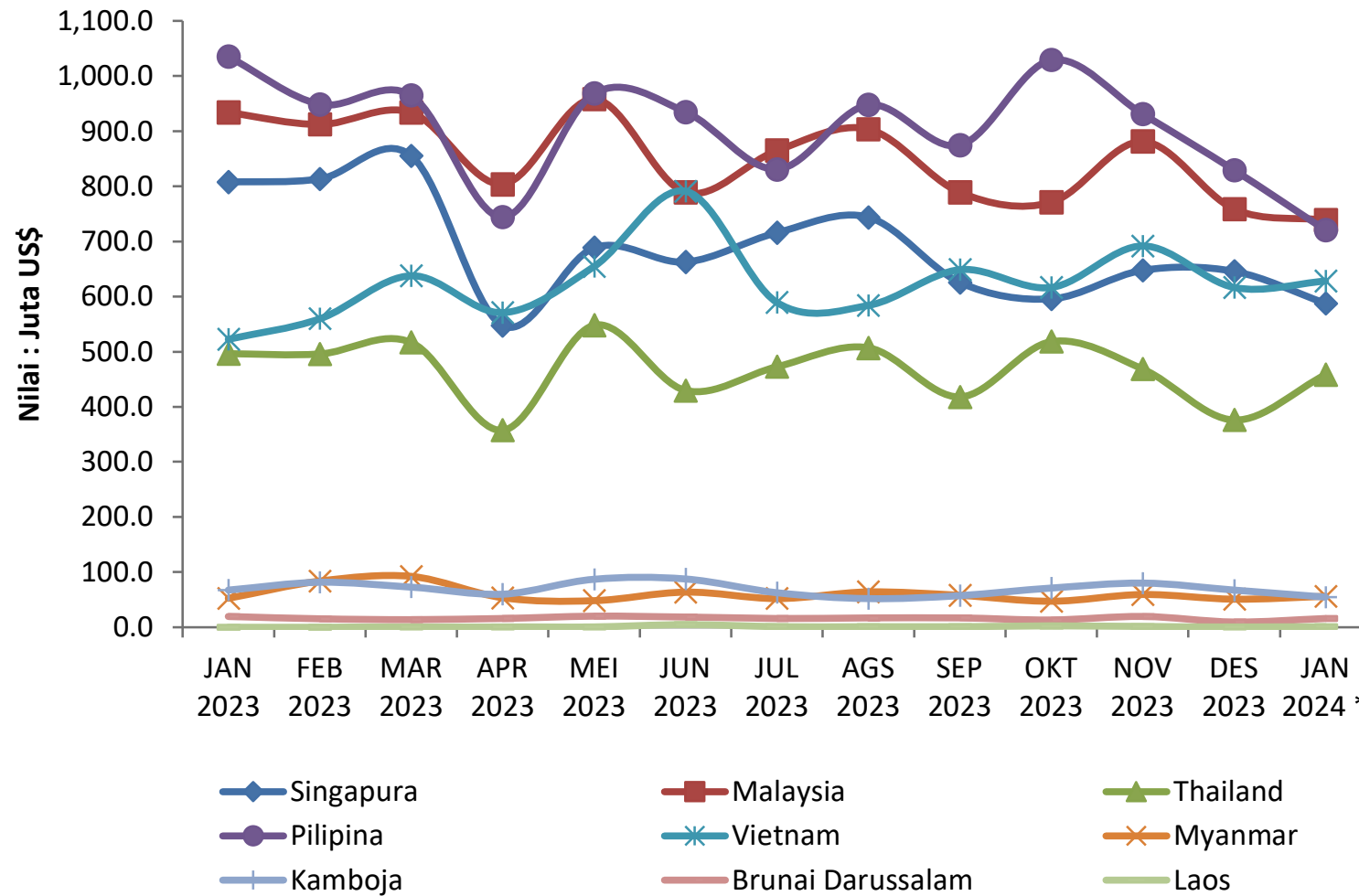

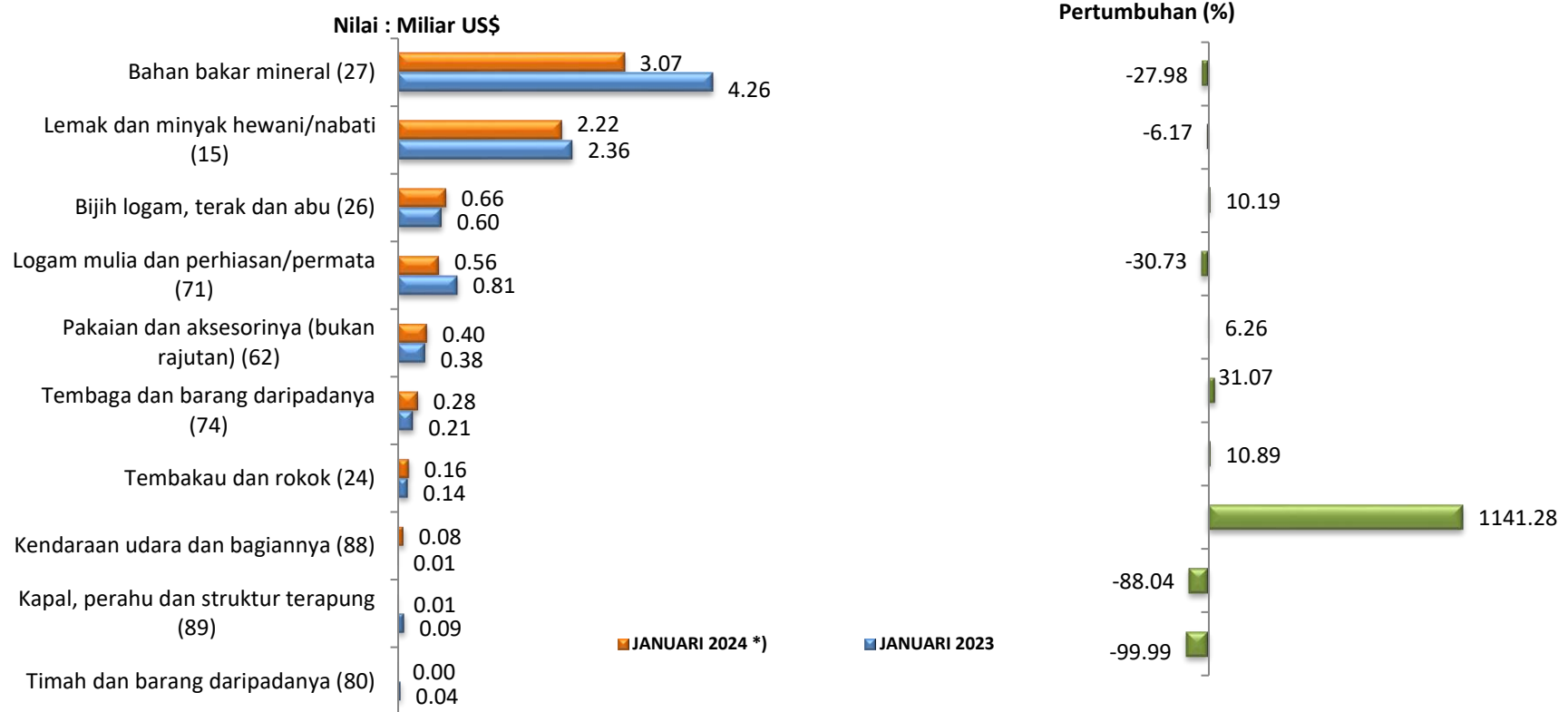

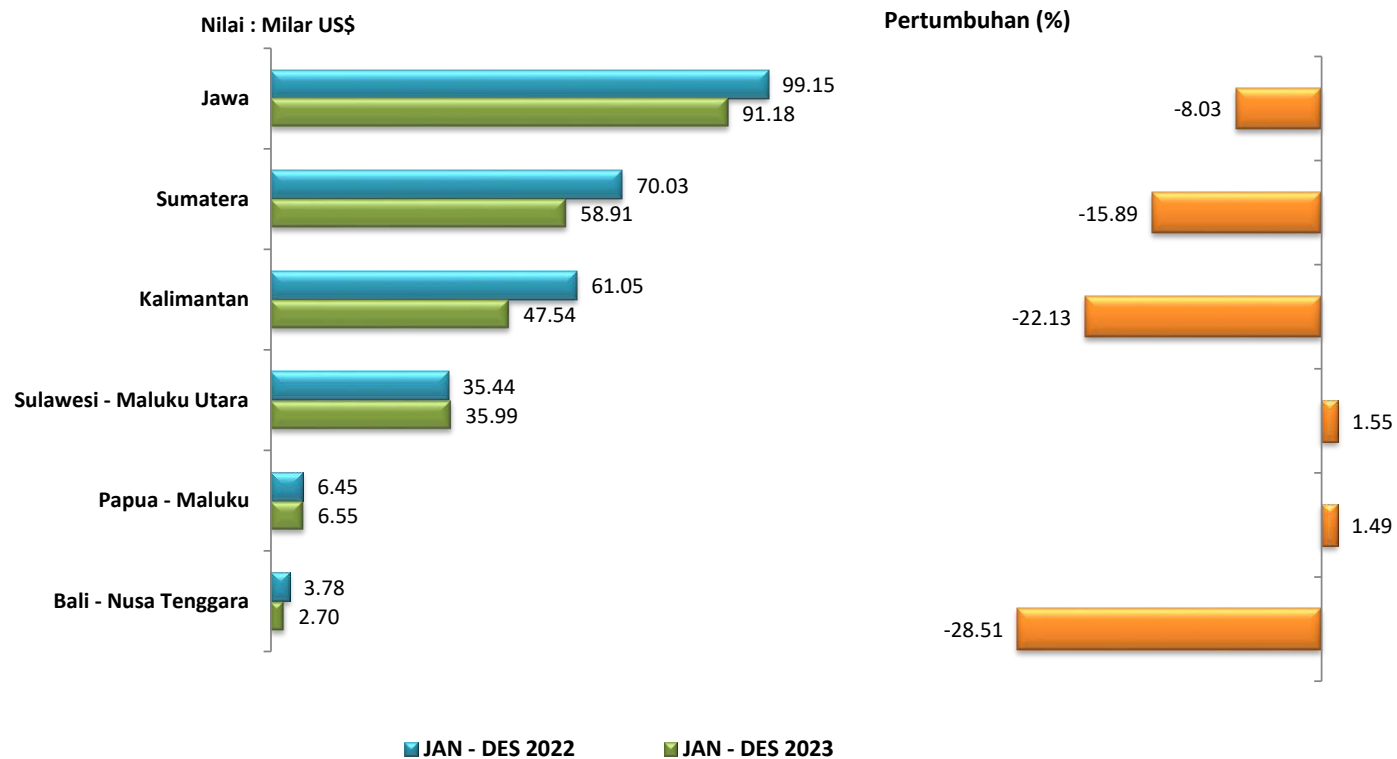

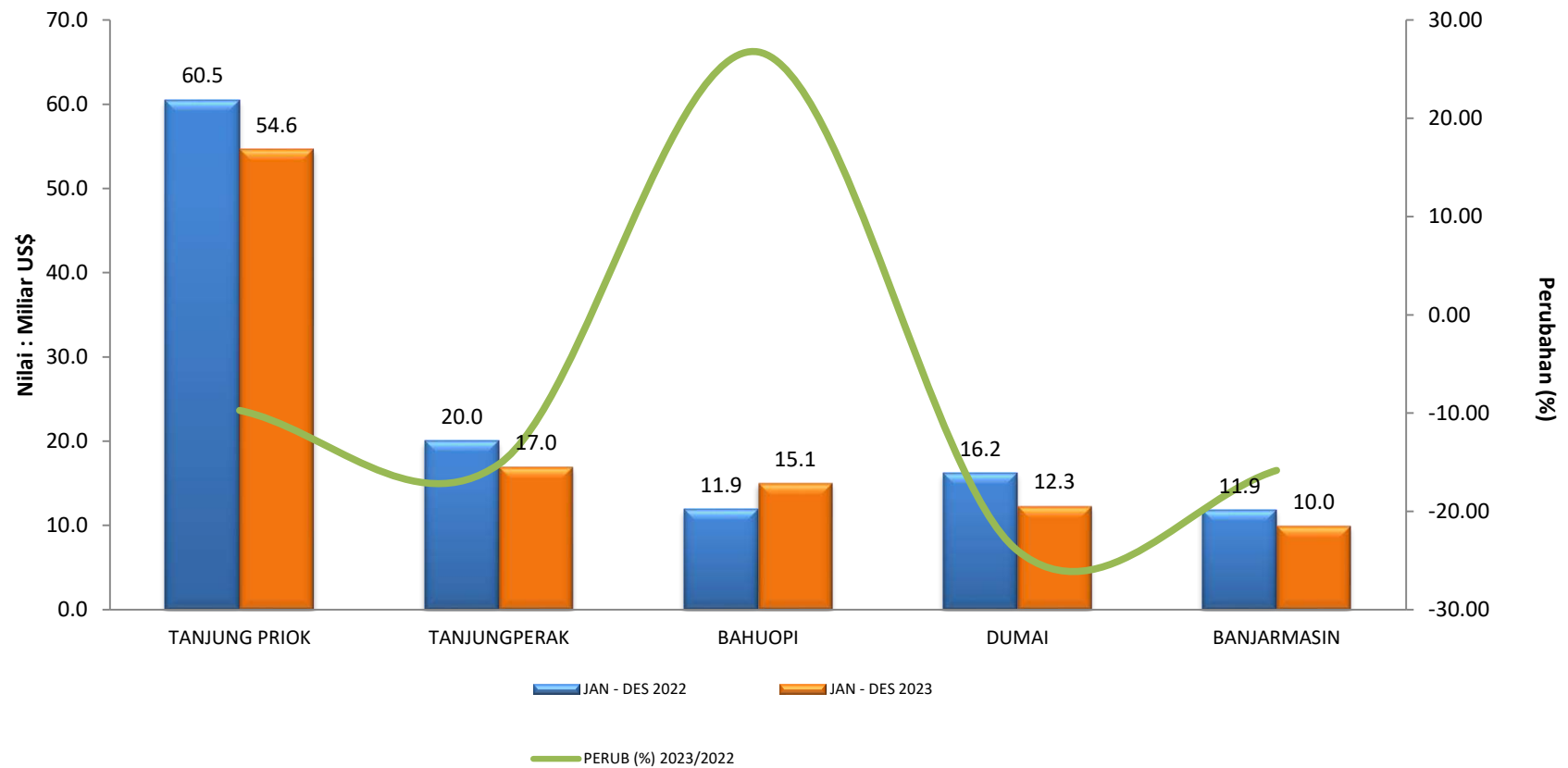

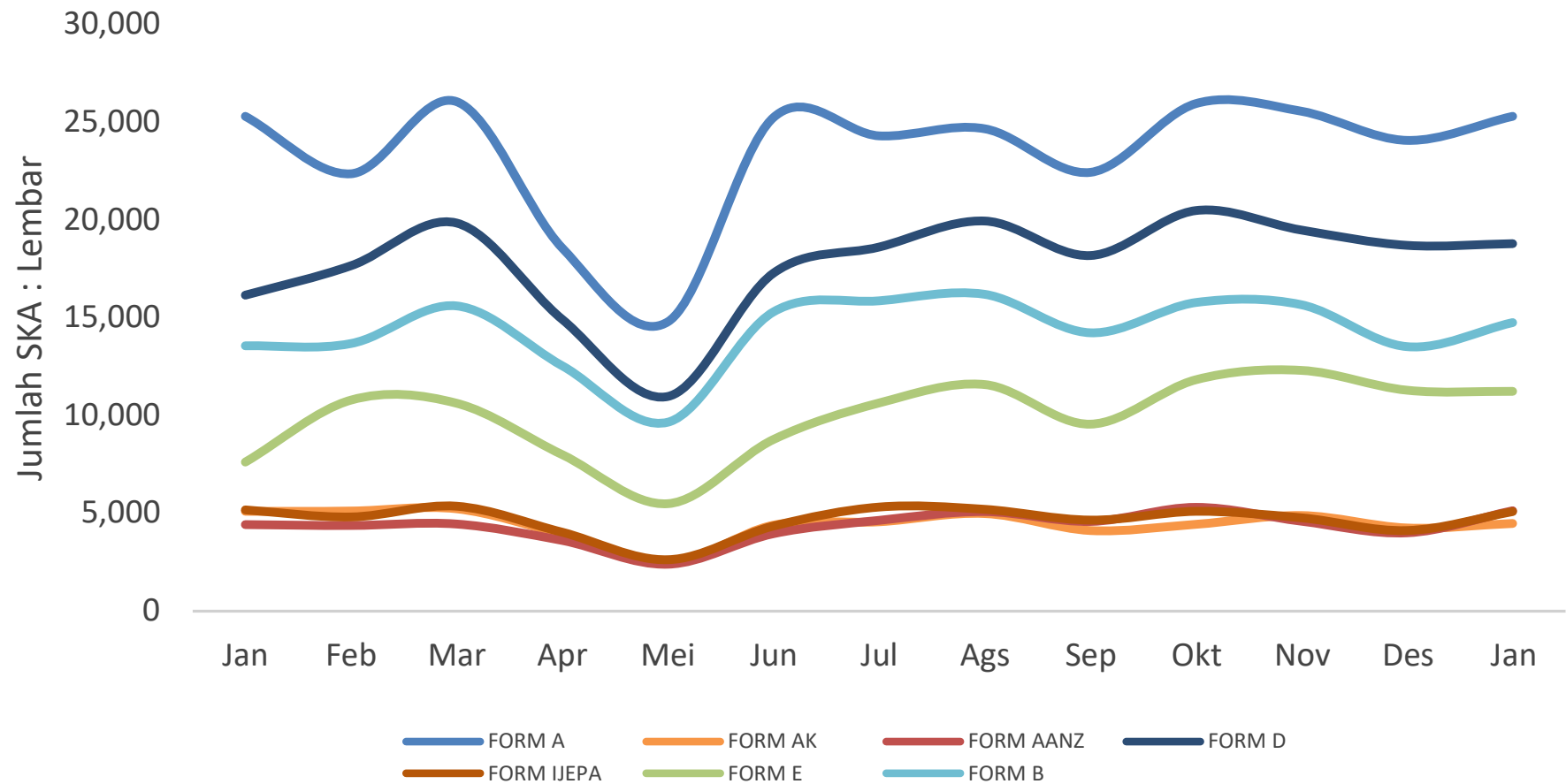

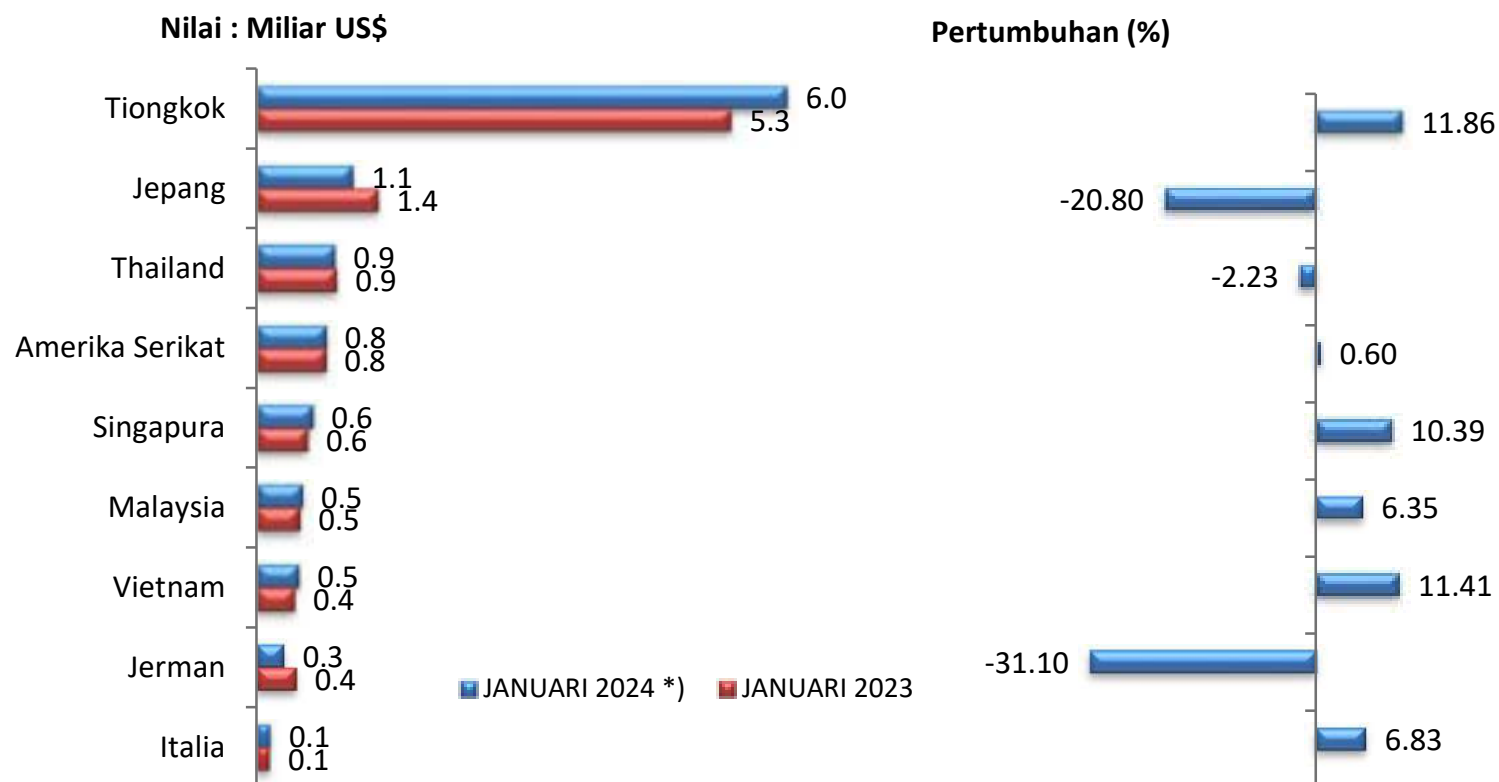

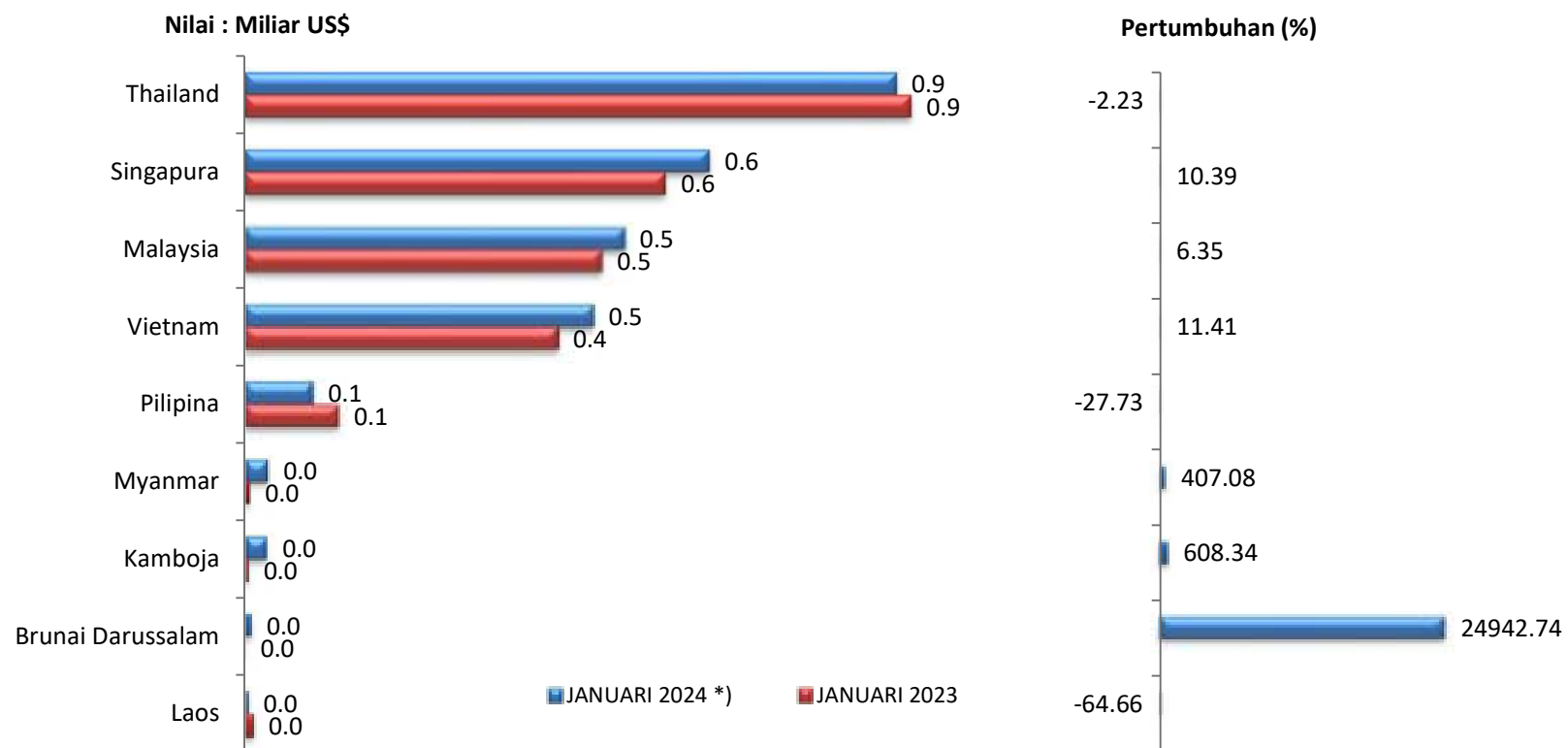

IMPOR NON MIGAS INDONESIA DENGAN ASEAN



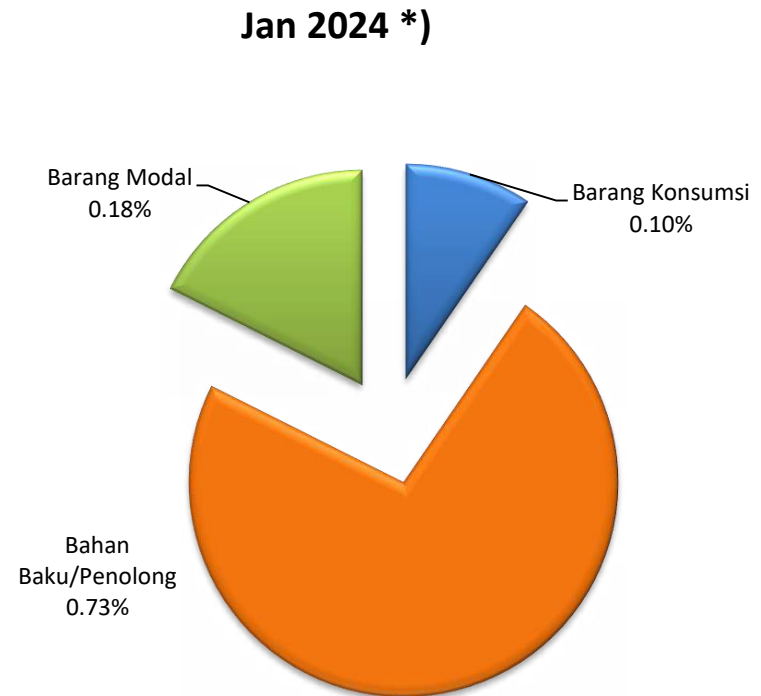
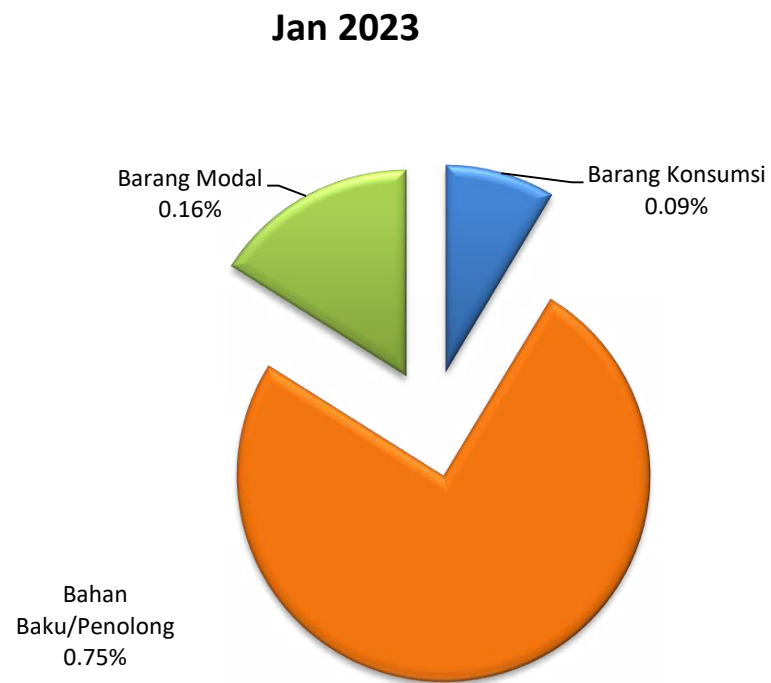

PERSENTASE IMPOR MENURUT GOLONGAN PENGGUNAAN BARANG



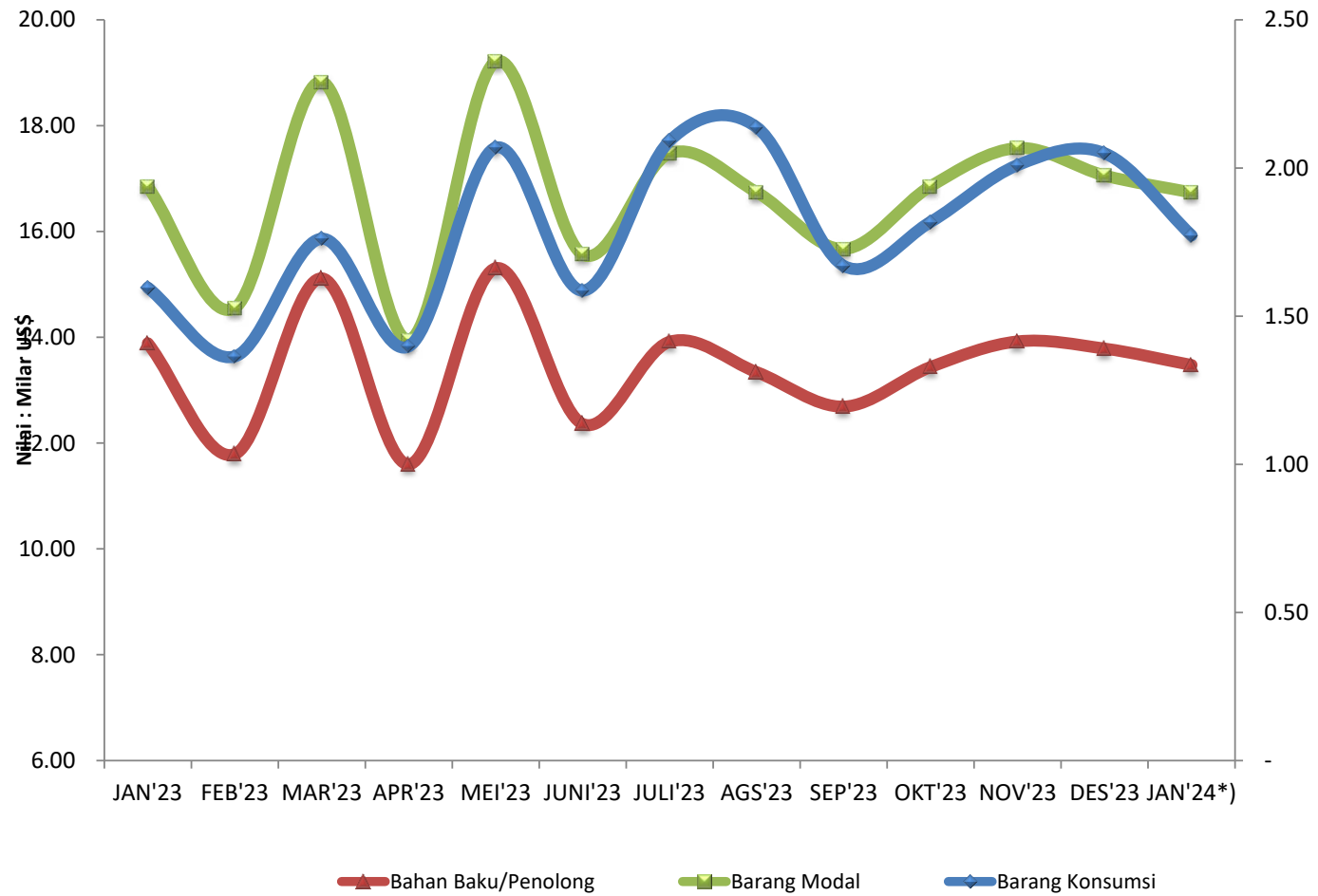

MENURUT GOLONGAN PENGGUNAAN BARANG



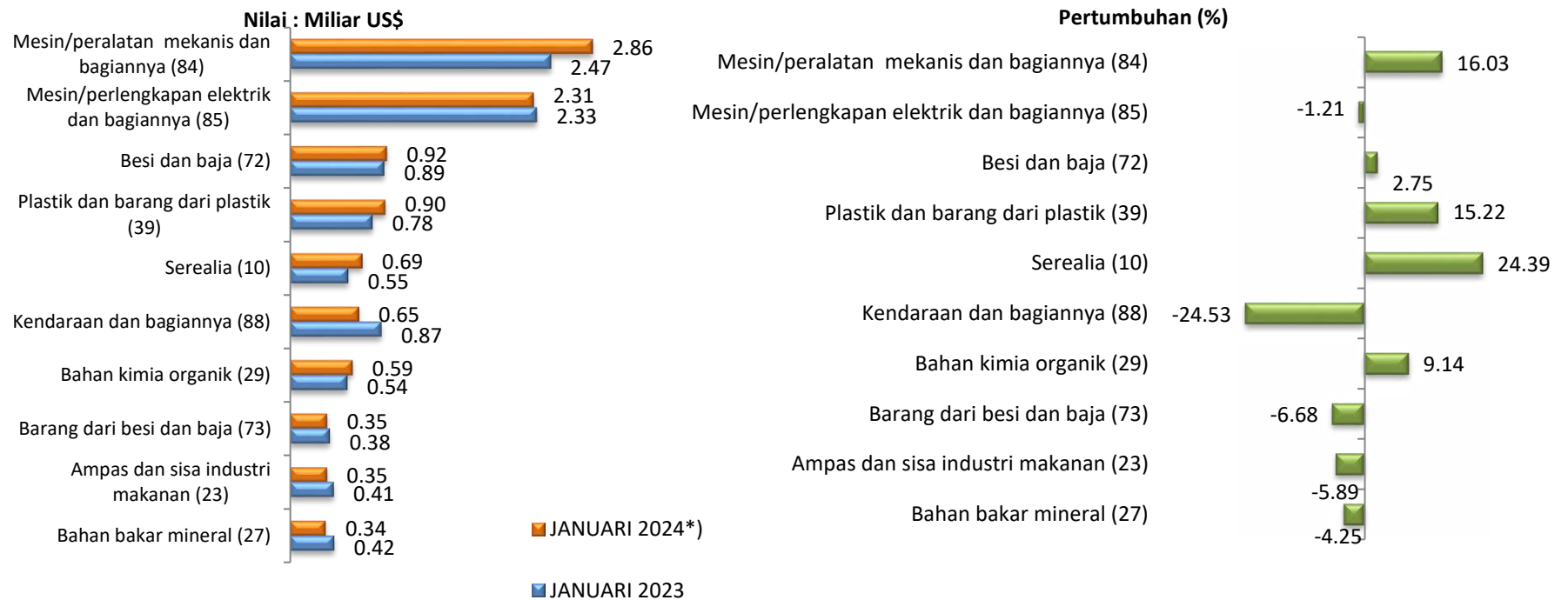

MENURUT HS 2 DIJIT



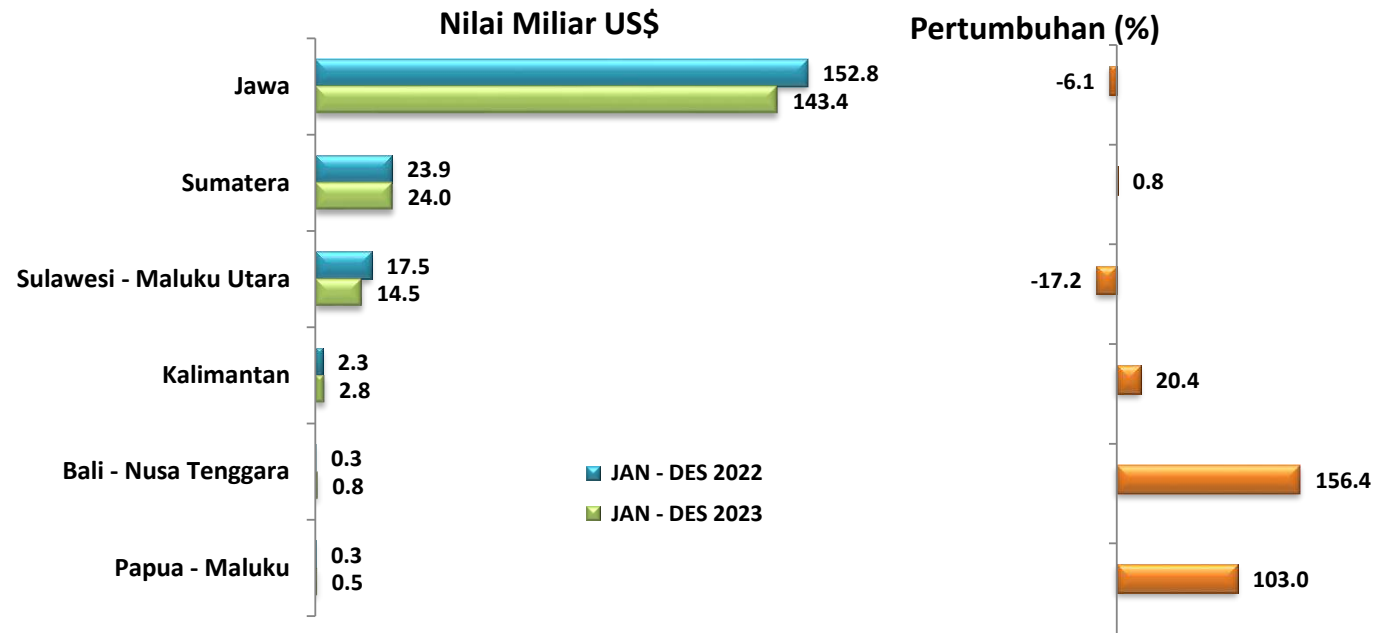

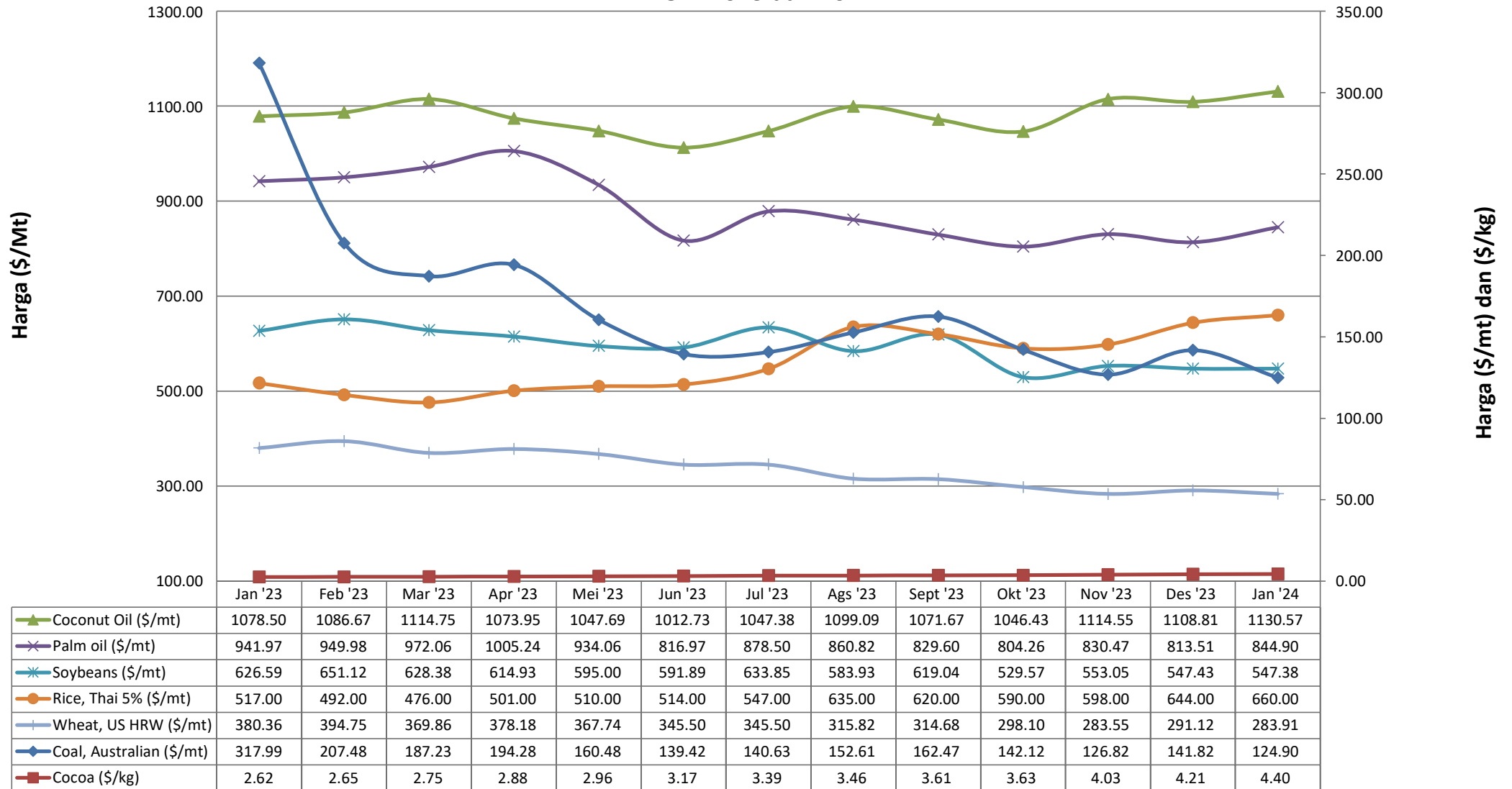

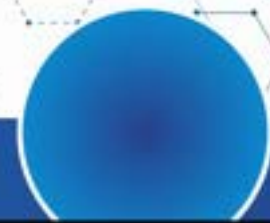

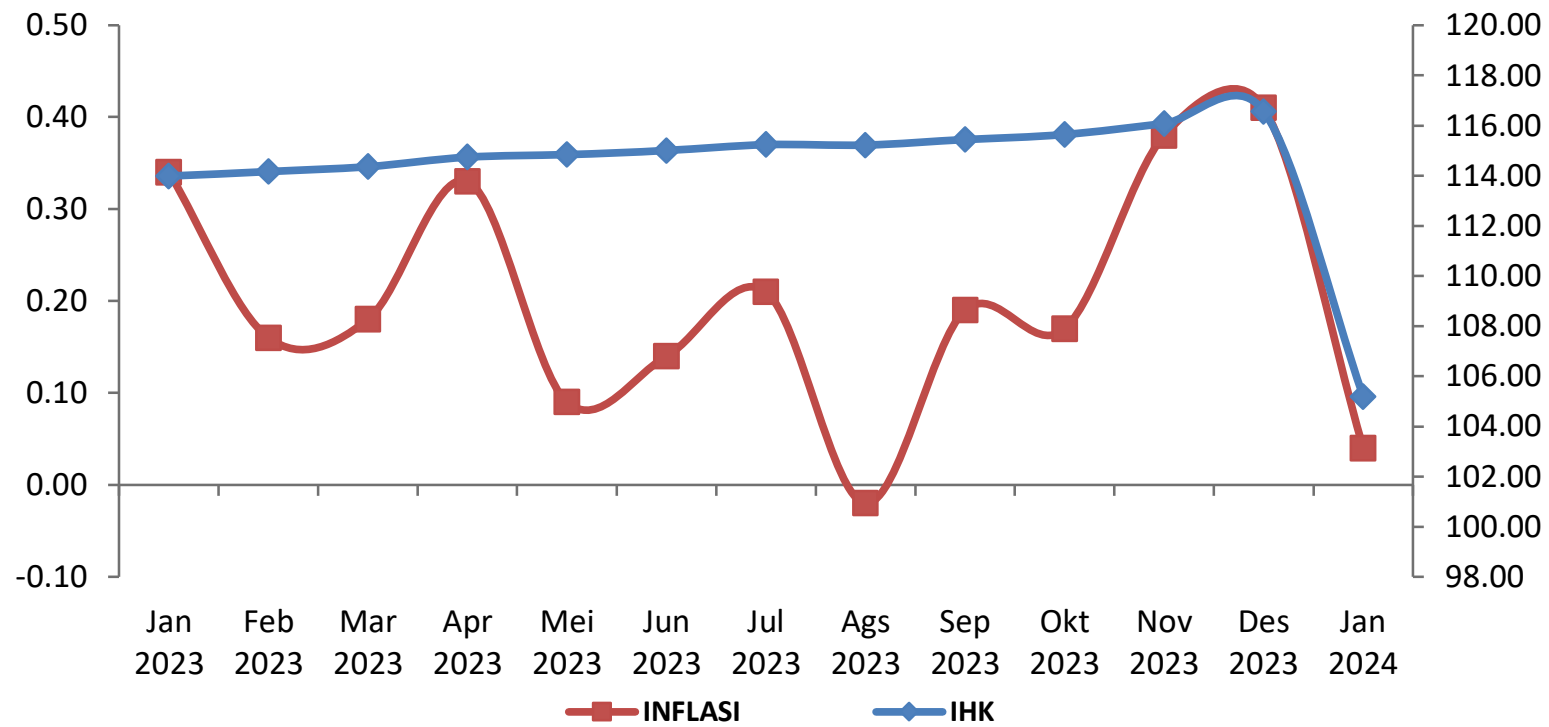
